WE HAVE INAUGURATED TWO NEW PROGRAMS: 2 WEEK-LONG RESIDENCIES FOR BIPOC ARTISTS FROM MN TO FOCUS SUPPORT AND FOSTER COMMUNITY ARTISTS OF COLOR AND ENSURE THAT THEY FEEL SAFE AND WELCOME IN NATURE, AND 2 WEEK-LONG NATIONAL EMERGING ARTISTS PROGRAM, TO SERVE AS A BRIDGE TO EARLY CAREER ARTISTS ACROSS THE COUNTRY AND ACROSS DISCIPLINES BY PROVIDING THEM WITH ARTISTIC COMMUNITY AND OPPORTUNITY FOR THEIR PROFESSIONAL EXPRESSION.
